- Consumption in excess of 100,000 gallons.....\$400.00 deposit

A \$40.00 cut-on fee is required for all customers. The deposit will be transferred if you currently have a deposit with the Town. When service with the Town is discontinued, the deposit will be applied to any balance left on the account and the remaining amount will be refunded.

Bills are printed at the end of the month, and are due upon receipt. If payment is not received by the twenty-first day of the month, a late fee of 15% will be added to the amount of the bill. If payment is not received by the tenth of the following month, service will be cut off until all balances have been paid.

If this is new construction, the Town will need to verify that the proper connection fees have been paid prior to the establishment of service.
